

**President's Report**

- St. Paul's: We had an executive meeting with St. Paul's just prior to our meeting tonight.
- ESST/Paid Leave: We are now in compliance, and Amie is working with Chris on a method to track (48 hours on payroll starting January 1). We have reported 3<sup>rd</sup> quarter time, and we need to report the 4<sup>th</sup> quarter time by 1/31. We also need a method to remember to report.
- Camera/Lock Quote: Jason and Jeff are working on the YALE locks (automatic locks). Southwest Glass can rekey the others.
- BMO/Banking: Still working on the treasurer having virtual access and statement reviews.
- Centralize information – Microsoft Office: E-mails are set up. Dawn and Jeff Van Keulen are working on backing up information and a database.
- Meeting with Altar Guild: They need additional members to learn the tasks that they do. Look into pairing confirmed youth with long time members?
- Additional Items to Work on:

Prayer chain–Looking to technology/best practices. / Constitutional amendment meeting – They will be taking a pause. Building committee meeting will take a pause. / Council packet for February meeting. Set up or meet with Music? / Looking ahead – Reverend Peter Soli follow-ups. Outreach / Social event – Winter 2026 Season; Lent – Soup/Service? / Record review/retention

**Secretary's Report – Motion made to approve secretary's report by Cory Myhre. Terri Myhre seconded the motion. Motion carried.****Treasurer's Report**

- Bills: Bills for the month of January were sent out prior to the meeting for review. Total General Fund bills are estimated at \$9,765.33 with two additional bills. **Motion made by Terri Myhre to approve the Treasurer's Report. Deb Belaen seconded the motion. Motion carried.**

**Board of Trustees Report**

- Bills: Total General Fund bills are estimated at \$9,765.33 with two additional bills: Prairie Conference dues of \$133.50 (based on 534 baptized members) and Peter Soli consulting services for \$1436.46 for the month of December (bill was for \$1936.46 with the \$500 deposit deducted).
- Budget Approval: The proposed budget was provided via e-mail. There is a 20% increase in insurance based on the current rate increases in the industry. There is also a 4% increase in the janitor's salary. The organist pay will also be increased from \$65 to \$70 per service. **Motion made by Terri Myhre to approve the proposed budget. Sandy Josephson seconded the motion. Motion carried.**
- Annual Meeting Agenda: The agenda was provided via e-mail. We agreed to move the elections and approval of the proposed budget to the beginning of the meeting as we did last year.
- Annual Reports: The annual reports for all committees are due to Chris by January 15<sup>th</sup>.
- Audit of Church Books: Chris has the books ready to be audited, so they can be audited at any time. Amie will reach out to several people to do this.
- MN ESST and Paid Leave: We are now up to date on all the requirements for these two items. This only applies to Chris, and the additional cost is included in the proposed budget under a separate line item.
- Proposed Disclosure Policy and Proposed Forms: Amie has been working on policies that the church as a non-profit should have in place. Amie had sent them out via e-mail a few weeks ago. She has drafted an Operational Ethics Policy based on the ELCA policy including a Conflict-of-Interest Disclosure form. She also proposed a Disclosure of Liens and Judgements form for those serving on as President and Treasurer of the council or on committees that manage money in that role. The second form would not be shared with the whole council but would be kept on file with the President of the Council. **Motion made by Deb Belaen to approve the proposed policy and associated forms drafted by Amie. Cory Myhre seconded the motion. Motion carried.**
- **Motion made by Barb Knutson to approve the Board of Trustees' report. Emily Hennen seconded the motion. Motion carried.**

- Confirmation / Youth of Hope:
  - Christmas Blessings Service Project was a huge success!! We were able to support families locally through Minneota Public School and Lyon County with hats and mittens for foster children with Southwest Health and Human Services.
  - Confirmation Retreat is March 6-8 at Inspiration Hills in Vining, MN. Details are still being worked on.
  - We will be attending a concert in Clara City on March 11, 2026, from 7 to 9 pm; the Sidewalk Prophets are performing.

## Hope Lutheran Teen Power's Annual Shoe Collection

Clean out your closets and bring your shoes, boots, sandals, and other footwear to Hope Lutheran Church! Give away your gently worn shoes to help to provide shoes that aren't worn or an old pair that may end up in a landfill. We will gather footwear and deliver our donations to one of the drop-off points, Schuler Shoes in St. Cloud, MN. They shared with us that after the footwear is donated, the shoes are paired and sorted, and the footwear goes to four different places. The newer ones may be donated to the shelter food shelf and then sold at shelters for \$5.00/pair. The money is then donated to the shelter's food shelf. Some of the shoes stay in Minnesota with a program called "Shoe Away Hunger", and some go to other countries where they are needed for people without shoes. The rest, if pretty worn out, or are singles, are shredded and used for playground surfacing of rubber mulch. **Please clean out your closets and bring your bags and boxes of your household's gently worn footwear to Hope Lutheran Church.**

## **February 2026 Council President's Newsletter Article**

The February Board Meeting began with the election of officers and the selection of committees. For 2026, the Deacons Committee will be led by Sandy (chair), with Nona, Barb, Lori, and Jason serving alongside her. The Education Committee includes Jasmine (chair), Angie, Jen, and Susan. The Executive Committee is made up of Amie (Council President), Jeff (Vice President and Treasurer), Deb (Secretary), and Cory. I had the opportunity to meet with the new council members prior to the first council meeting for onboarding, and I am grateful for their willingness to serve. Each brings unique gifts and perspectives, and I look forward to the ways God will work through them as we move forward together as one church body. If you have questions or concerns related to any of these areas, please feel free to reach out to a council member or to me. Open communication and mutual support help keep us united in our shared mission.

One of the most meaningful nights for Hope Lutheran Youth Ministries each year is Grandparents Night. The energy is truly unmatched as students invite a grandparent or another important person in their life to share a GLOW night together. This year, the evening also included a service project benefiting the local food shelf. Participants colored taco kit content sheets and packed food items—kits that are especially appreciated, as these items cannot be purchased through Second Harvest. Each child and adult also decorated a picture frame, which will hold photos taken that evening as a lasting reminder of their shared experience.

The worship message focused on family trees, reminding us that we are a family rooted deeply in faith—connected to God and to one another like a strong, living tree. Thank you to everyone who participated and helped make this night so special. The week prior, students practiced being good neighbors by creating Valentines that were donated to **Minneota** Assisted Living and another local nursing home. During a meeting I recently **attended**, several ideas for additional community service were shared, and I warmly invite you to pass along any service ideas or opportunities you may have. Serving together is one way we live out our faith in unity.

The annual meeting was adjourned and will continue on March 1, 2026. This action was taken because, after the vote to approve the new council members and budget, a quorum was no longer present. At the continued meeting, the previous reports will be approved to ensure clarity and transparency regarding those votes taken. You might ask yourself - a quorum? what is needed and why is it that? Our quorum of 50 members, as well as the structure of the meeting agenda, is defined by the Hope Lutheran Constitution. Prior to adjournment, a Call to Order was made for a second vote on a constitutional amendment. The council voted to approve setting a date for this vote. A special meeting will be held before the continuation of the annual meeting on March 1, 2026. A Notice of Special Meeting has been issued outlining the proposed agenda and procedures. Again, there must be fifty voting members for a quorum to be met for the special meeting to proceed.

Finally, the Deacons have developed a plan regarding weather-related decisions for Sunday services. Jason, Sandy, and Amie will consult together, with the goal of making a decision by Saturday when possible. The Deacons are also working on a backup plan so that worship may still take place when conditions allow. In the event of a cancellation, announcements will be shared via Marshall Radio, Facebook, and the church website. While the church communication app is unlikely to be ready for weather events this year, work is underway to make that possible in the future.

Reverend Peter Soli started in January working with the steering committee – which is Jessica Moriarty, Lori Dyce, Terri Myhre, and Roberta Josephson. If you are interested in being a part of the steering committee, please contact myself, a council member, or steering committee member regarding.

As we move through these decisions and ministries together, let us continue to extend grace, patience, and encouragement to one another. We are strongest when we walk together in faith, grounded in Christ and united in love.
